Important points:


1. The details of tuition fee per annum to be paid at the time of admission for various BFA and B.Design courses are given in the above table.
2. Candidates who are eligible for fee reimbursement as per JVD norms:
 - i) The total family annual income to be less than or equal to Rs.2.50 lakhs.
 - ii) The total land holding of the family to be less than 10.00 acres of wet or 25.00 acres of dry or 25.00 acres both wet and dry land together.
 - iii) No member of the family should be a government employee/pensioner (all sanitary workers irrespective of their salary/recruitment, are eligible. The Social Welfare Department shall develop a robust & fool-proof system of certification of parents of the beneficiaries under category of "Sanitary workers").
 - iv) No member of the family should own a four-wheeler (The members of the family who are provided Taxies/Tractors/Auto under Government sponsored schemes are exempted).
 - v) A family who owns no property or less than 1500 Sft of built up area (Residential or Commercial) in urban areas is eligible.
 - vi) No member of the family should be income tax payee.
3. Those who are submitting Income certificate of their parent must bring the latest copy from Tahsildar of their respective location.
4. In case if government does not reimburse the equivalent fee as specified, the candidate has to pay the balance tuition fee to the University.
5. All other candidates admitted under regular admissions and spot admissions should pay the stipulated equivalent fee as specified by the University at the time of Admission.
6. Library caution deposit of Rs.3000/- for all the students who get admission and the deposit will be refundable after completion of the course.
7. If the seat allotted to a candidate is cancelled for any valid reasons before the closure of the admissions, the tuition fee paid by the candidate will be refunded after deducting 10% of the tuition fee prescribed for that course. In case, if a candidate wants to cancel the seat after the closure of the admissions, the candidate is required to pay the fee as per the norms of the University in order to receive back his/her certificates. A separate Transfer Certificate will be issued to such candidates.

Original Certificates should produced at the time of Counselling/Admission:

- i. Transfer Certificate from the college last studied (TC).
- ii. Marks memo of Qualifying Examination (Intermediate/ 10+2/ Diploma etc.).
- iii. SSC/ 10th Class marks memo).
- iv. Caste in case of SC/ST/BC (from Caste Certificate issued by MRO).
- v. PH, NCC, Sports, CAP etc. (from certificate issued by competent authority)

- vi. EWS Certificate.
- vii. Income of parents (latest 'Income Certificate' issued by MRO) within Six Months..
- viii. Study / bonafide certificate from 6th class to Intermediate or residence certificate or relevant certificate for proof of local status (from study / bonafide certificates issued by School / College) from the concerned authorities.
- ix. Recent passport size colour photograph – 8 No.
- x. Printout of the online filled Application.
- xi. Candidate Aadhar card copy.
