DETAILED NOTIFICATION**

- ❖ The qualified and eligible candidates of GPAT are informed to attend APPGECET-2025 web counseling for admission into M. Pharmacy – Pharm.D (PB) courses for the academic year 2025-26 as per the schedule given below.
- ❖ Candidates are informed that they should satisfy the admission rules prescribed in the related G.O. besides satisfying the eligibility criteria of the respective Universities and should be prepared to pay the tuition fee as applicable.
- ❖ The notification itself is a call for counseling. No separate call letters will be sent to the individual candidates.
- ❖ Mere applying for counseling does not guarantee a seat.
- ❖ Candidates GPAT have to pay Registration fee online in <https://cets.apsche.ap.gov.in> from 09-07-2025 onwards. Registration Fee for SC/ST Candidates is Rs: 300/- and for others Rs: 600/-
- ❖ GPAT qualified candidates have to pay counseling fee from 07-09-2025 through online <https://cets.apsche.ap.gov.in>. For web counseling Fee for SC/ST Candidates is Rs: 500/- and others Rs: 1000/-.
- ❖ Counseling fee shall be paid online using credit card/debit card/net banking options.
- ❖ Visit <https://cets.apsche.ap.gov.in> using Micro soft Edge and click on pay fee online.
- ❖ Enter GPAT Hall Ticket number & rank and click on pay fee online.
- ❖ Select any one mode of payment credit card / debit card/ net banking and enter credentials. Once the transaction is successful, note the transaction ID and upload at the time of attending certificate verification.

GPAT Candidates seeking admission into M. Pharm / Pharma. D (PB) colleges are requested to note the following Fee Types applicable to various courses while exercising options.

RGS: Regular Course-GPAT Candidates are ELIGIBLE for AICTE scholarship

RGN: Regular Course- GPAT Candidates are NOT ELIGIBLE for AICTE scholarship

SFS: Self Finance - GPAT Candidates are ELIGIBLE for AICTE scholarship

SFN: Self Finance -GPAT Candidates are NOT ELIGIBLE for AICTE scholarship

GPAT Candidates NOT ELIGIBLE for Reimbursement of Tuition Fee by the State Government

Pharma.D (PB): Candidates are NOT ELIGIBLE for AICTE Scholarship.
